Any Local 410 member in good standing is eligible to be nominated for the office of President, Secretary/Treasurer, Regional Representative or Unit Chair and must be nominated by another Local 410 member in good standing. Members running for the position of Regional Representative must be a member of the respective unit in the region for which they are nominated. Any member of a unit can be nominated for unit chair by any other member of that unit, provided both members are in good standing.

A member can only be nominated for one (1) executive board position, and in the event they are nominated for more than one position, the nominee must declare to the Elections Committee at the close of nominations the position for which they intend to run.

Nominations will be open from April 30<sup>th</sup>, 2025, to May 21<sup>st</sup>, 2025, following which the Local 410 Elections committee will conduct an election as needed for any positions using our online voting system.

Voting will be conducted during May 22<sup>nd</sup>, 2025, to June 12<sup>th</sup>, 2025, ending at noon. Results to be released on the afternoon of June 12<sup>th</sup>, 2025.

All nomination forms must include the name and signature of both the nominator and nominee, and the position for which the nominee is being nominated using the form below.
